# **Sweepstakes Rules**

### 1. Eligibility

Energy Efficiency Gift Bundle Sweepstakes (the Sweepstakes) is open to legal residents of the state of Arizona, USA who are at least eighteen (18) years old at the time of entry. ## 4. Sweepstakes Period

The Sweepstakes begins on February 15, 2014 at 6:00am MST-AZ and ends on April 30, 2014 at 11:59pm MST-AZ (the Sweepstakes Period). Entries that are submitted before or after the Sweepstakes Period will be disqualified. Submissions will be accepted for the duration of the Sweepstakes using any of the following methods: Online Sweepstakes.

#### 5. How to Enter

Online: This method of entry will be available by visiting our website (www.elahomerepairs.org) and following the directions provided to fill out the entry information, and submit.

Limit one (1) entry per person, per method, and per household for the duration of the Sweepstakes Period. Entry limit one (1) Facebook account, (1) Twitter account, and (1) Email address. ## 6. Prize Drawing

On or about May 01, 2014, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about May 01, 2014. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

#### 7. Winner Notification

The potential winners will be notified by email, mail or phone. Each potential Grand and 2nd Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize.
